RESOLUTION 2025-94

A resolution to approve the license charge schedule for the Implementation and Administration of the Campground Rules November 6^{th} , 2025

- The Board of Health of Huron County Public Health, Huron County, Ohio met at a regular meeting of the Board, on November 6th, 2025 at 1:00 p.m.; whereupon the following was placed in consideration on the regular agenda of the Board:
- **WHEREAS**, the Board of Health of Huron County Public Health has completed a cost methodology in compliance with Chapters 3729.07 and 3709.09 of the Ohio Revised Code and 3701-36-14 of the Ohio Administrative Code; and
- **WHEREAS**, the Board of Health of Huron County Public Health, to properly implement and administer 3701-26 of the Ohio Administrative Code, repeals the District portion of the license charges schedule established in Resolutions 2024-86; and
- **NOW THEREFORE BE IT RESOLVED**, the license charges have subsequently been evaluated and voted upon after three public readings and a public hearing with the Board voting as indicated below. An electronic copy of Resolution 2025-94 will be maintained at the District's office for proper record keeping and reporting purposes.
