## GRANT OPPORTUNITIES

### **-Better Bike Share Partnership Mini-Grants:**

These grants are funded by the PeopleForBikes Foundation as part of the Better Bike Share Partnership and range from \$2,500 – \$10,000. They're available to any non-profit community-based organization, municipality, or shared mobility operator working to make bike share more equitable and inclusive.
