RESOLUTION 2025-107 Emergency Establishment of Sewage Professional registration fees October 9, 2025

The Board of Health of Huron County Public Health, Huron County, Ohio met at a regular meeting of the Board, on October 9, 2025, at 1:00 p.m.; whereupon the following was placed in consideration on the regular agenda of the Board:

WHEREAS, the Ohio Revised Code and the Ohio Administrative Code mandates and allows for health districts to establish certain fees and charges; and

WHEREAS, the District is required by the Ohio Department of Health's programs to recover certain fees by resolution; and

WHEREAS, because after three readings, the effective date of the fees will not be enacted prior to December 1st, 2025; and

WHEREAS, the immediacy of change in relation to registration renewals requires the District to pass this resolution as an emergency by repealing the specific current local permit and service fee categories established in Resolution 2024-89 listed below and establishing new local permit and service fee categories/fees without proper notification to the public,

WHEREAS, that the foregoing resolution was adopted and all actions and deliberations of the Board of Health of Huron County Public Health, Huron County, Ohio relating thereto were conducted in meetings open to the public, in compliance with all applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

NOW THEREFORE, BE IT RESOLVED, the Board of Health hereby approves the following local permit and service fees to become effective October 9, 2025.

STS Service Provider registration	\$ 187.01
Septage Hauler, Cleaner, Portable Registration	\$ 150.62
Septage Vehicle Inspection	\$ 64.72
