### RESOLUTION 2022-85

#### A resolution to approve the fee schedule for the Implementation and Administration of the Food Service Operation and Retail Food Establishment Rules October 6, 2022

The Board of Health of Huron County Public Health, Huron County, Ohio met at a regular meeting of the Board, on October 6<sup>th</sup>, 2022 at 1:00 p.m.; whereupon the following was placed in consideration on the regular agenda of the Board:

**WHEREAS**, the Board of Health of Huron County Public Health has completed a cost methodology in compliance with Chapters 3701-21 and 901:3 of the Ohio Administrative Code; and

**WHEREAS**, the Board of Health of Huron County Public Health, to properly implement and administer 3701-21, 3717-1, and 907:3-4 of the Ohio Administrative Code, repeals the District portion of the fee schedule established in Resolution 2021-92; and,

**NOW THEREFORE BE IT RESOLVED**, the fees have subsequently been evaluated and voted upon after three public readings and a public hearing with the Board voting as indicated below.
