## RESOLUTION 2025-99

### A resolution to approve the service fee and license charges schedule for the implementation and administration of the Resident Camp Program

November 6<sup>th</sup>, 2025

The Board of Health of Huron County Public Health, Huron County, Ohio met at a regular meeting of the Board, on November 6<sup>th</sup>, 2025 at 1:00 p.m.; whereupon the following was placed in consideration on the regular agenda of the Board:

**WHEREAS,** the Board of Health of Huron County Public Health, who voted as certified below under Chapter 3709.09 of the Ohio Revised Code, establishes fees and license charges intended to offset the cost of the authorization for the operations of Resident Camps; and

**WHEREAS,** the Board of Health of Huron County Public Health, to properly implement and administer 3701-25 of the Ohio Administrative Code, repeals the District portion of the service fee and license charge schedule established in Resolutions 2024-91; and

**NOW THEREFORE BE IT RESOLVED,** the service fee and license charges have subsequently been evaluated and voted upon after three public readings and a public hearing with the Board voting as indicated below. An electronic copy of Resolution 2025-99 will be maintained at the District's office for proper record keeping and reporting purposes.
