A resolution to approve the service fee and license charge schedule for the Implementation and Administration of the Public Bathing Place Regulations November  $6^{\rm th}$ , 2025

The Board of Health of Huron County Public Health, Huron County, Ohio met at a regular meeting of the Board, on November 6<sup>th</sup>, 2025 at 1:00 p.m.; whereupon the following was placed in consideration on the regular agenda of the Board:

WHEREAS, the Board of Health of Huron County Public Health has completed a cost methodology in compliance with Chapter 3709.09 of the Ohio Revised Code; and

WHEREAS, the Board of Health of Huron County Public Health, to properly implement and administer the Public Bathing Area Regulation, repeals the District portion of the service fee and license charges schedule established in Resolutions 2024-88; and

**NOW THEREFORE BE IT RESOLVED**, the service fee and license charges have subsequently been evaluated and voted upon after three public readings and a public hearing with the Board voting as indicated below.
