WHEREAS, the Board of Health of Huron County Public Health, to properly implement and administer 3701-09 of the Ohio Administrative Code, repeals the District portion of the service fee and permit charges schedule established in Resolutions 2024-90; and

NOW THEREFORE BE IT RESOLVED, the service fee and permit charges have subsequently been evaluated and voted upon after three public readings and a public hearing with the Board voting as indicated below.
