RESOLUTION 2026-92

A resolution to approve the 2027 Environmental Health Division Service Fees, License Charges, Permit Charges, and Fine Schedules for the Implementation and Administration of Environmental rules and programs October 8th, 2026

The Board of Health of Huron County Public Health (“Board of Health”), Huron County, Ohio met at a regular meeting of the Board on October 8th, 2026, at 1:00p.m.; whereupon the following was placed in consideration on the regular agenda of the Board:

WHEREAS, the Board of Health, acting under the authority vested in it by Section 3709.21 of the Ohio Revised Code, may adopt regulations necessary for public health and safety and for the prevention and restriction of disease; and,

WHEREAS, license fees are adopted in the form of rules under authority of Section 3709.09 of the Ohio Revised Code; and,

WHEREAS, Retail Food Establishment License Fees are adopted in the form of rules under authority of Section 3717.25 of the Ohio Revised Code; and,

WHEREAS, Food Service Operation License Fees are adopted in the form of rules under authority of Section 3717.45 of the Ohio Revised Code; and,

WHEREAS, the Ohio Department of Health has established rules governing the categories and methodology for establishing fees; and,

WHEREAS, the adopted fees are necessary to cover the costs of administering the environmental health programs; and,

WHEREAS, the Board has conducted three public readings and held a public hearing regarding the fees set forth in Sections 1 and 2, in accordance with the requirements of the Ohio Revised Code; and

WHEREAS, that the foregoing resolution was adopted and all actions and deliberations of the Board of Health of Huron County Public Health, Huron County, Ohio relating thereto were conducted in meetings open to the public, in compliance with all applicable legal requirements, including Section 121.22 of the Ohio Revised Code.

NOW THEREFORE BE IT RESOLVED, after giving due thought and proper consideration, that the Board of Health hereby:

1. Repeals the District portion of the service fees, license charges, permit charges, and fine schedules established in Resolutions 2025-93, 2025-94, 2025-95, 2025-96, 2025-98, 2025-99, 2025-120, 2025-121, effective on the equivalent effective date of the new service fees, license charges, permit charges, and fine schedules established by this Resolution; and
2. Adopts the service fees, license charges, permit charges, and fine schedules as set forth in Sections 1 and 2 below, effective on the dates specified therein.

PRESENTED, ADOPTED, APPROVED AND RECORDED this 8th day of October, 2026. An electronic copy of Resolution 2026-92 will be maintained at the District's office for proper record keeping and reporting purposes.
